**Terms & Conditions:-**

1. All orders and correspondence raised by the trade agencies to the farmer's' federations/Groups \individual to the farmer's' federations/Groups \individual should be copied to the marketing cell, U.O.C.B.
2. The trade shall take place entirely between the agency and producers group as directed by UOCB.
3. Transaction certificates shall be issued to the trade agency only upon requirement.
4. Trade agencies are obliged to maintain the chain of custody of the products till the retail point. The trade agencies is required to contact our Marketing Cell (Ph -0135-2662770,2662771 ).For Understanding the complete sequence of organic supply chain for problem free flow of documents .
5. Source of origin and other details should appear in the retail pack these should be approved before final printing.

6. The final retail packing of the produce should be made available to the U.O.C.B.
7. The trade agency shall use the name Organic Uttarakhand, U.O.C.B., C.O.F., Himvanaya only after approval of the U.O.C.B.
8. Any feedback from the consumers shall be sent to trade agency and those are obliged to be considered for being taken into consideration and inclusion.
9. U.O.C.B. reserves the right for cancellation of registration of any agency.
- 10 **Annual registration fees of Rs 5000/-** will be charged from the trade partners. UOCB will obtain service charge for the different services provided on the basis of the total invoices generated by the farmers group to the buyers in a financial year.

Against the registration and the service charge obtained by UOCB the buyer/ traders gets the package of benefits which it can avail time and again, the different benefits are as follows:-
